## Timing and Usage

Growers can rely on Aprovia to help prevent diseases in their vineyards when correct application timing and usage rates are followed. Aprovia should be used at a rate of 7 to 10.5 oz/A every 7 to 14 days.

- For Powdery Mildew, begin applications at bud break with a recommended 14 day interval.
- For Phomopsis, begin applications at bud break, before shoots are 0.5 inches in length. Apply again when shoots are 5 to 6 inches in length.


